As you can see, we have a couple of vacant positions on the Board of Directors. According to our corporate By-laws, we are required:

The Corporation shall have a minimum of eight (8) members on the Board of Directors elected by the general membership. An additional Director position may be included on the Board, as needed, and elected by the general membership.

Please read over the job descriptions and help us out. Board nominations are taking place at our October meeting, and elections are in November. Talk to another Board member to see how we do business, planning meeting and fundraisers, decisions we make, places we meet, etc. And check out all board positions while you are considering.

**DIRECTOR-AT-LARGE or PARLIAMENTARIAN:** Is the "good will ambassadorship" for the members: providing get well cards, sympathy cards, & "sunshine" correspondence where needed on behalf of the Board of Directors.

**PUBLIC RELATIONS DIRECTOR:** is responsible for the monthly newsletters & responding to or forwarding email received in the general ACWN email box. Coordinates photos, advertising, articles, & distribution of the monthly newsletter. Ensures the newsletter is posted on the ACWN website; posts updates to the "What's Happening" page & coordinates all ACWN events & information with the media.

**PRESIDENT:** supervises the affairs of the Corporation and performs all duties incident to the office as provided in the Bylaws; provides an agenda for the monthly Board of Directors meetings & presides over such meetings; and maintains the official records – transactional and financial.

VICE-PRESIDENT: is chairperson of the Program Committee: arranges and organizes programs & speakers for meetings; performs all duties & exercises all powers of the President when the President is absent or is otherwise unable to act.

**TREASURER:** has charge & custody of all funds of the corporation: makes deposits; keeps & maintains financial records; reports to the Board of Directors monthly; files all appropriate tax returns with federal & state governments prior to due dates; updates Corporation entity with State of California as required.

**MEMBERSHIP DIRECTOR:** maintains accurate membership records for those members paid and those with dues outstanding. Is chair of Membership Drive committee. Coordinates with the Director of Reservations and the Social Media Liaison to ensure the membership directory on the ACWN website is current & accurate. Coordinates with the Public Relations Director for publishing the Annual Member Directory & maintains name tags.

**SECRETARY:** keeps minutes of the Annual Meeting, special meetings required by the Board, & all meetings of the Board of Directors and is responsible for picking up, logging, & distributing mail received from the ACWN post office box.

**RESERVATIONS DIRECTOR:** oversees reservations for monthly meetings. Is responsible for coordinating the venue & attendance of the general membership to the monthly meetings; transfers monies received at lunches to the Treasurer & new membership information to the Membership Director.
